The quartet Ariadni Vatopoulou, Theodosia Katsarou, Jamila Chriouat, and Simos Michalopoulos—followed with a performance of the song "Dust in the Wind" by Kansas.

Ms. Eva Tsoukalidou, a Supreme Court lawyer and financial consultant, was then welcomed to the stage, inspiringly highlighting the power we, as teens, hold as the future generation in these rather demanding times.





The anthropologist Nefeli Voulieri talked about the history of Lesvos and the crisis that erupted there back in 2015. She shared her insightful point of view on the topic through her personal experiences and thoughts.

Then, a video summarizing the agenda of the conference was presented to the auditorium.

The opening ceremony concluded with an astonishing speech by the Secretary General, Mr. Karqiotis.

Overall, the opening ceremony of the 8th DSTMUN was one of a kind, setting the tone for the conference we had all been awaiting!

Updates of the GAs

The GA1 committee worked actively on preventing the recruitment of ethnic minorities in armed conflicts and insurgent groups. After icebreakers that helped build rapport, delegates presented their policy statements and proceeded to lobbying. The chairs remained highly engaged and looked forward to productive debates.


The GA2 committee addressed barriers to banking for the unbanked and economically excluded. Delegates quickly presented their policies and moved into lobbying on both their main topic and the issue of regulating digital currencies to prevent financial crimes.

The GA3 committee addressed issues under the Social,
Humanitarian, and Cultural agenda. The session began with
icebreaker activities to establish rapport among the delegates.
Delegates then presented their policy statements, outlining their
countries' positions, before moving into lobbying. During the
discussions, several delegates highlighted their national
challenges, while others expressed agreement or raised
concerns regarding the proposed viewpoints.

The GA4 committee discussed the assessment of affirmative action policies for Indigenous representation in government and legislative bodies. Delegates presented their policy statements, outlining their nations' positions on the matter. The committee also focused on addressing statelessness and safeguarding nationality rights for displaced and vulnerable populations in the Middle East and North Africa.

The People the World Keeps Ignoring

In a world drowning in headlines, certain tragedies slip through the cracks. While everyone's focused elsewhere, the Yazidis grieve endless losses from ISIS attacks that never got closure. While leaders argue over penalties, partnerships, or shipping paths, whole ways of life inch toward vanishing. Still, even when ignored, they won't fade away.





In the distance, the Rohingya are stranded without land or refuge, and most people ignore their demolished homes. Being Hazara by birth can put one in danger everywhere in Afghanistan, where schools and places of worship are repeatedly bombed. Inside China, Uyghurs disappear into camps where customs are subtly lost and concealed from prying eyes. These groups are united by a more difficult bond -the anguish of being ignored-rather than by geography or customs. Because their struggles don't benefit those in power, marginalized voices become less heard as political noise increases, not because they want to be silent.




Still, even when ignored, they won't fade away. One Yazidi mom keeps looking for her lost child.
